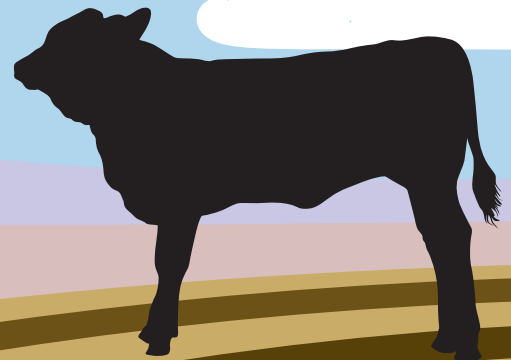

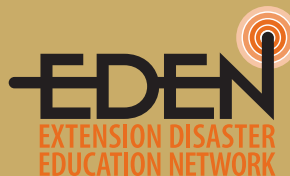

MARIANNE ASH
DVM, DACVPM has been the director of Biosecurity and Emergency Programs of the Indiana State Board of Animal Health since 2002, and is an adjunct Professor for the Department of Veterinary Clinical Sciences, School of Veterinary Medicine, Purdue University.

**ANDY VESTAL**

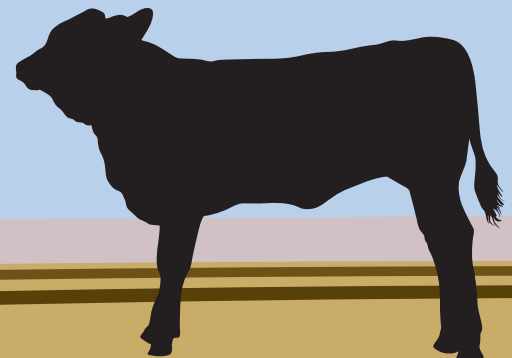
is a professor and Extension specialist for Homeland Security and Emergency Management with Texas AgriLife
